U.P. STATE ENERGY CONSERVATION AWARD - 2018

Award for Excellence in Energy Conservation and Management

OBJECTIVE

To give state level recognition to the Industrial units, building establishments, Institutes, Hotels, Hospitals, Banks and Architects, who have made systematic and serious attempts for efficient utilization and conservation of energy during the years 2017-18 in comparison to 2016-17.

THE AWARDS

First, Second and Third prizes are proposed to be given in these sectors in the form of a Shield with appropriate citation on such awards as may be decided by the Award committee. The performance of the unit would be judged through a questionnaire (format enclosed) which would be evaluated by an Award Committee.

The Award Committee would take a final decision on the number of awards depending on the number and quality of entries received in each category. Hence, there may be possibility that first, second or third award may be cancelled i.e. only one or two prizes may be given, if number of quality entries are not received.

SECTORS

- 1. Industries General Category (having connected load 1MW and above, except Thermal Power plant, Fertilizer Industry & Sugar Industry) -- Sector Code: IN-A
- 2. Industries General Category (having connected load less than 1MW) -- Sector Code: IN-B
- 3. Thermal Power Plant -- Sector Code: TP
- 4. Fertilizer Industry -- Sector Code: FZ
- 5. Sugar Industry Sector Code: SI
- 6. Private Buildings (Shopping Malls/ Plazas/Corporate Offices etc. excluding hotels / hospitals) -- Sector Code: PB
- 7. Government Buildings (Central/ State Government offices, Government Agencies/Corporation etc. excluding Govt. hotels / Govt. hospitals) -- Sector Code: GB
- 8. Hospital -- Sector Code: HS
- 9. Hotel -- Sector Code: HT
- 10. Educational Institutions -- Sector Code: El
- 11. Banks (Financial Institutions) -- Sector Code: FI
- 12. Architects -- Sector Code: AR

ELIGIBILITY CRITERIA

Sector Wise Criteria

The scheme is open to all Industrial units, building establishments, Banks/Financial Institutions and Architects of Uttar Pradesh having minimum following participation criteria:

- Banks (Financial Institutions) -- Sector Code: FI
 - The scheme is open to all public as well as private Financial Institutions (FIs) including Banks and Non-Banking Financial Centers (NBFCs), registered with RBI.

- Private Buildings (Shopping Malls/ Plazas/Corporate Offices etc.) -- Sector Code: PB
 - The scheme is open to all commercial buildings, which are having covered area 500 sq. meter and above or having connected load of 100 kW and above or both.
- Government Buildings (Central/ State Government offices, Government Agencies/Corporation etc.) --- Sector Code: GB
 - o The scheme is open to all Govt. buildings of Uttar Pradesh.
- Thermal Power Plant -- Sector Code: TP
 - The scheme is open to all Thermal Power Stations of Uttar Pradesh using coal, gas and other resources as fuel for production of electricity.
- Fertilizer Sector -- Code: FZ
 - The scheme is open to all fertilizer units of Uttar Pradesh who are manufacturing fertilizer.
- Sugar Industry -- Code: SI
 - The scheme is open to all Sugar units of Uttar Pradesh who are manufacturing Sugar.
- Industries General Category (having connected load 1MW and above, except Thermal Power plant, Fertilizer Industry & Sugar Industry) -- Sector Code: IN-A1
 - The scheme is open to all industries of Uttar Pradesh except Fertilizers, Power Plant and Sugar having connected load 1MW and above.
- Industries General Category (having connected load less than 1MW) -- Sector Code: IN-B1
 - o The scheme is open to all units of Uttar Pradesh having connected load less than 1MW.
- Hotel -- Sector Code: HL
 - The scheme is open to all hotels of Uttar Pradesh having connected load 100 KW and above.
- Hospital -- Sector Code: HS
 - The scheme is open to all Hospitals/Nursing Homes having connected load 100 KW and above
- Educational Institutions -- Sector Code: El
 - The scheme is open to all educational institutions established in Uttar Pradesh
- Architects -- Sector Code: AR
 - The scheme is open to all architects / architectural firms or architects working in construction company established in Uttar Pradesh

General Criteria

- Participants should not have been debarred / blacklisted / penalized by any of the Govt. Institutions including concerned DISCOM and Income Tax Department or other taxation departments...
- Participant organization should be located in geographical boundary of Uttar Pradesh.
- The architects are eligible who have designed a building located in Uttar Pradesh.

In case of Banks/financial Institution having office outside Uttar Pradesh may also participate
if their regional office and branches are in Uttar Pradesh and the organization financed is
located in Uttar Pradesh and premises of organization received finance from bank is located
in Uttar Pradesh.

Criteria for Judging Merit

- a) Evaluation of the nominations will be done, based on the Evaluation and Weightage criteria as given in **Annexure-B**, attached with **Award Questionnaire**.
- b) Evaluation will be made on the basis of the information, as required in "Award Questionnaire: Proforma-I" and "Detailed Information of Energy Efficiency Projects: Proforma-II" along with "Write-Up in Annexure-A".
- c) The members of the Award Committee or their nominees may visit participating units for verification of data supplied, if felt necessary and it will be obligatory on the part of the participating units to provide necessary co-operation.
- d) Director NEDA's decision would be final and no appeal would be entertained.

Instructions for Filling up the 'Award Questionnaire':

- a) Please read all the documents carefully.
- b) The data required for the questionnaire should pertain to the accounting years 2016-17, 2017-18.
- c) The enclosed questionnaire is only a format and thus information sought should be downloaded from Website: www.upneda.org.in or / and www.upsavesenergy.com.
- d) Participants need to register and join the energy saving campaign at www.upsavesenergy.com.
- e) The answers to the questions should be precise, specific and should be supplied in total compliance with the questionnaire format. The deviations may lead to improper evaluation or the rejection of the nomination.
- f) Participants need to submit a write- up (format enclosed) of its own establishments along with soft copy (word format) through emails or pen drive or CD/DVD.
- g) The information on prescribed format will only be accepted, however if some details are to be provided e.g. list of projects etc. the same may be attached.
- h) Each and every query mentioned in the questionnaire needs to be answered. Even, if answer is 'NO' or `NOT APPLICABLE' the same may be stated, instead of ignoring it.
- i) The questionnaire should be filled in by a competent and responsible person of the company. The duly filled-in questionnaire and other documents as desired should be approved and signed by the Chief Executive or Authorised signatory of the participating units.
